REQUESTING COVERAGE FROM A THIRD PARTY PAYER FOR SPEECH, OCCUPATIONAL AND PHYSICAL THERAPY FOR A CHILD UNDER AGE 3

The California Department of Managed Health Care requires your health plan to provide speech, occupational and physical therapy to your child if it is medically necessary. The plan is prohibited from excluding children with a developmental delay or specific diagnoses from receiving these therapies. It is also prohibited from arbitrarily limiting the number of therapy sessions that may be provided.

If you believe your child needs one of these therapies you should:

- Ask your health plan to provide the service to your child. If you are told that the services are not medically necessary, ask for your child to be assessed.
- If the health plan denies your request for an assessment or for the service, you should appeal the denial. Information about how to appeal will be included in the letter informing you of the denial.
- If the health plan denies your appeal or does not respond to your appeal within 30 days, you should request an independent medical review (IMR) from the Department of Managed Health Care. Information about the IMR process will be included in the denial letter. You can also obtain information about the process at www.hmohelp.ca.gov or by calling 888-HMO-2219.
- If the health plan authorizes one of these therapies for your child they may do periodic assessment of his or her progress to see if the treatment continues to be medically necessary.

The Department of Managed Health Care regulates all HMO plans and PPO plans provided by Anthem Blue Cross Blue Shield. If your health plan is not regulated by DMHC, you may request independent medical review from the Department of Insurance. You may call 800-927-4357 or visit their website,

More about Third Party Coverage for Speech,
OT and PT

This document offers guidance to parents who wish to request coverage under their health plan for speech, occupational or physical therapy for their son or daughter under the age of 3. (For children over 3, these therapies are usually provided by the school district.) The information applies to health plans that are regulated by the Department of Managed Health Care (DMHC). These include all Health Maintenance Organizations (HMOs) in California as well as Preferred Provider Organization (PPO) plans offered by Anthem Blue Cross Blue Shield.

What therapies does my health plan cover?

Services and supplies that your health plan covers and excludes from coverage can be found in a document called the Evidence of Coverage, or EOC. You should receive an EOC from your employer or directly from your health plan on an annual basis. If you do not have one, you should request a copy. These documents may also be available on your health plan's website.

Third party health plans are generally required to cover *health services* that are *medically necessary*. Since PT, OT, and speech are health services, they should be covered by your health plan if they are medically necessary for your child.

Until now, many California health plans have specified that these therapies are covered only for the purposes of *rehabilitation*. Typically, this means that if a health plan member suffers an event, such as a stroke or traumatic head injury, these therapies may be provided to

return him to his previous level of functioning – i.e., to rehabilitate him. For a child with a developmental delay, the purpose of these therapies is typically not rehabilitative since they would be intended to help the child develop new skills.

The Department of Managed Health Care (DMHC) which regulates a majority of health plans in California has made the decision that health plans will no longer be allowed to categorically exclude speech, PT and OT for children or set arbitrary limits on the number of sessions, since these services qualify as health services. The Department has stated that they will be directing health plans to change their EOCs to make it clear that these therapies are available to children *when medically necessary*.

What does this mean for me and my child?

This means that if you believe your child needs speech, OT or PT you should request an assessment for that therapy from your health plan. The health plan is obligated to do an assessment. If the assessment determines that your child needs therapy, the health plan must provide it. Once services have begun, however, the health plan may institute a *utilization review* process. This means that they may periodically evaluate your child's progress in therapy to see if continuation is warranted – in other words, to determine if your child is making progress and if the services continue to be medically necessary.

What should I do if my health plan refuses?

If you request speech, OT or PT for your child and the health plan refuses to provide it, you should appeal that decision. Information on how to appeal will be included in the letter that you receive informing you of the health plan's decision not to cover the therapy.

Generally, a health plan must respond to your appeal within 30 days. If they deny your appeal or if you have not received a response to the appeal

within 30 days, you may request an Independent Medical Review (IMR) from the Department of Managed Health Care. Information about the IMR process and how to get help is available at www.hmohelp.ca.gov or by calling 1-888-HMO-2219. The letter informing you of the denial of your appeal should also include information about the IMR process.

If your health plan is point of service (POS), an exclusive provider organization (EPO), or a PPO other than Anthem Blue Cross Blue Shield, it is not regulated by DMHC. Such plans also offer an independent medical review process, but it is provided through the California Department of Insurance. You may get information on this IMR process by calling 800-927-4357, or by visiting the Department of Insurance website, www.insurance.ca.gov.

Solicitud de Cobertura de un Pagador de Terceros **para**
Terapia de lenguaje, Terapia Física y Ocupacional
Para niños menores de 3 Años

El Departamento de Control de Cuidado de Salud de California requiere que su plan de salud provea a su niño(a) con terapia de lenguaje, física y ocupacional siempre y cuando esta sea una necesidad médica. El plan tiene prohibido el excluir a niños(as) con retrasos del desarrollo o con un diagnóstico específico de que reciban estas terapias. También tiene prohibido el limitar arbitrariamente el número de sesiones de terapia que pueden ser proveídas.

Si usted cree que su niño(a) necesita una de estas terapias usted debe de:

- Solicitar al plan de salud que le provea el servicio a su niño(a). En caso de que la respuesta sea el que su niño(a) no tiene una necesidad médica para el servicio, solicite el que le hagan una evaluación.
- En caso de que el plan de salud rechace su petición por una evaluación o por el servicio, usted debe de apelar la negación. Información referente a como usted puede apelar estará incluida en la carta que le informe la negación.
- En caso que el plan de salud niegue su apelación o no responda a su apelación a no más tardar 30 días de usted haber enviado la petición, usted tiene que solicitar una Revisión Médica Independiente (IMR) de parte del Departamento de Control de Cuidado de Salud de California. La Información referente al proceso de IMR será incluido en la carta de negación. Usted también puede obtener información referente a este proceso al visitar la página Web al www.hmohelp.ca.gov o al llamar al número de teléfono 888-HMO-2219.

En caso de que el plan de salud autorice alguna de estas terapias para su niño, puede que se soliciten evaluaciones periódicamente para evaluar el progreso y necesidad de las terapias.

El Departamento de Control de Cuidado de Salud de California regula todos los planes de HMO y PPO que son proveídos por medio de Anthem Blue Cross Blue Shield. En caso de que su plan de salud no es regulado por DMHC, usted puede solicitar una revisión médica independiente por medio del Departamento de Seguros. Usted puede contactar al Departamento por teléfono al 800-927-4357 o al visitar la página Web www.insurance.ca.gov.

Información más detallada de las responsabilidades de su plan de salud y lo que usted puede hacer para recibir servicios para su niño(a) puede ser encontrada en las siguientes páginas.

Más información sobre la cobertura de un

Este documento ofrece una guía a padres que desean solicitar a su plan de salud que pague por servicios de terapia de lenguaje, terapia ocupacional o física para su niño(a) menores de tres (3) años. (Para niños mayores de tres (3) años la escuela usualmente paga por estas terapias). Esta información es aplicable para planes de salud que son regulados por el Departamento de Control de Cuidado de Salud de California (DMHC). Estas incluyen a todas las Organizaciones de Mantenimiento de Salud (HMOs) en California al igual que Organizaciones de Proveedores Preferidos (PPO) planes que son ofrecidos por Anthem Blue Cross Blue Shield.

¿Qué tipo de terapia ofrece mi plan de salud?

La información referente a servicios y materiales que su plan de salud cubre y excluye puede ser encontrada en el documento titulado Evidencia de Cobertura (EOC). Usted debe de recibir una copia del EOC de parte de su empleador o directamente de su plan de salud cada año. Si usted no tiene una copia, debería de solicitar una copia. Estos documentos también están

disponibles en la página Web de su plan de salud.

Planes de salud de terceros fondos (third party) generalmente son requeridos para cubrir los *servicios de salud* que son *necesarios médicamente*. Ya que PT, OT, y terapia de lenguaje son servicios de salud, estos deben de ser cubiertos por su plan de salud, si es que su niño(a) tiene una necesidad médica.

Hasta el momento, muchos planes de salud de California han especificado que estas terapias están cubiertos únicamente para los fines de la rehabilitación. Típicamente, esto significa que si un miembro del plan de salud sufre de un evento, como un accidente cerebro vascular (infarto) o traumatismo craneoencefálico, estas terapias pueden ser proveídas para ayudar al miembro a regresar al nivel de funcionamiento parecido o similar de antes del trauma, en otras palabras para rehabilitarlo. Para un niño(a) con un retraso de desarrollo, el propósito de estas terapias es típicamente no de rehabilitar ya que el propósito es ayudar al niño(a) a desarrollar nuevas habilidades

El Departamento de Control de Cuidado de Salud de California (DMHC) el cual regula la mayoría de planes de salud en California, ha tomado la decisión de que los planes de salud ya no se permite excluir categóricamente la terapia del lenguaje, OT, PT para niños(a) o para fijar límites arbitrarios sobre el número de sesiones, ya que estos servicios califican como servicios de salud. EL Departamento de Control de Cuidado de Salud de California (DMHC) ha indicado que le pedirán a los planes de salud que hagan cambios necesarios en el EOC para que se haga claro el hecho que estas terapias están disponibles para niños(as) cuando es médicamente necesario.

Qué significa esto para mí y para mi niño(a)?

Esto significa que si usted cree que su niño(a) necesita terapia de lenguaje, OT o PT usted debe solicitar una evaluación a su plan de salud para que *¿evalúe a su niño(a)*. El plan de salud está obligado a hacer una evaluación. En caso de que la evaluación indique que su niño(a) necesita

terapia, el plan de salud tiene que proveer la terapia necesaria. Una vez que los servicios empiezan, el plan de salud puede instituir el proceso de *revisión de utilización de servicios*. Esto significa de que el plan de salud haga evaluaciones del progreso de su niño(a) en terapias periódicamente para determinar si el servicio continua siendo necesario – en otras palabras, para determinar si el niño(a) está progresando y el servicio continua siendo una necesidad medica.

¿Qué puedo hacer si mi plan de salud reusa servicios?

Si usted solicita terapia de lenguaje, OT o PT para su niño(a) y su plan de salud reusa proveer el servicio, usted debe de apelar la decisión. Información en como apelar estará incluida en la carta que le indicara la decisión de su plan de salud de no cubrir por la terapia para su niño(a).

Generalmente, un plan de salud tiene que responder a su apelación a no más tardar 30 días de que usted somete su apelación. Si el plan de salud rechaza su apelación o si usted no recibe una respuesta después de 30 días, usted puede solicitar una reunión de Revisión Medica Independiente (IMR) de parte del Departamento de Control de Cuidado de Salud de California (DMHC). Información referente al proceso de IMR y como recibir ayuda esta disponible en la pagina Web www.hmohelp.ca.gov o al llamar por teléfono al 1-888-HMO-2219. Una carta informándole de la negación de su apelación también debe de incluir información referente al proceso de IMR.

En caso de que su plan es un Plan de Punto de Servicio (POS), una Organización de Proveedores Exclusivos (EPO), o un PPO aparte de Anthem Blue Cross Blue Shield, no esta regulado por DMHC. Tales planes también ofrecen un proceso de revisión médica independiente, pero es proveído por medio del Departamento de Seguros de California. Usted puede obtener información referente al proceso de IMR al llamar al numero de teléfono 800-927-4357 o al visitar la pagina Web del Departamento de Seguro, www.insurance.ca.gov.



SUMMERTIME CAMPING



If you're thinking about camp for your child this summer, now is the time to start planning.

Choosing the right camp is not a simple matter. Homework is necessary. Spend time checking out any camp thoroughly before you send your child. After all, you want to be certain that the camp is appropriate for your child's special needs and most of all, you want your child to have a *great* experience. Do not be afraid to ask questions such as: Can the camp make the proper modifications to meet the needs of your child? Do they have trained staff? Have the staff personnel been with the camp for a long time, or is their counseling experience limited? Is there a proper ratio of staff personnel to the number of children each counselor is responsible for? Is the camp management as well as the staff familiar with your child's particular disability, able to react to your child's special needs like food requirements and medical attention?

And then...visit the camp yourself to meet the staff, tour the facility and to see exactly what they offer. You can also check with the American Camping Association (www.acacamps.org) to find out more about the camp you're considering.

So get busy now if you're thinking about camp for your child this summer. Here are just a few suggestions for your child's summer experience:
